#### Litigation Department of the Year (General) Finalist: Skadden, Arps, Slate, Meagher & Flom

hatare some of the department's most satisfying successes of the past year and why?

Skadden's New York litigation department, comprising 200-plus of our nearly 600 strong global litigator roster, is often called upon by clients due to our expertise championing cutting-edge legal issues and unearthing innovative solutions to their most complex legal challenges. We remain at the forefront of the hottest legal trends that have broader economic implications and the potential to shape new law.

We have been the firm of choice for a variety of first-of-its-kind fintech and cryptocurrency class action representations. In a case of first impression, we obtained the dismissal with prejudice of a securities class action brought against crypto-focused hedge fund Paradigm Operations and other backers of decentralized digital asset trading protocol Uniswap, and, on behalf of Maker Ecosystem, we won the dismissal of a class action involving alleged losses suffered by users of the MakerDAO decentralized finance protocol.

We lead the defense bar on the securities litigation front, having defended more federal securities actions and federal securities class actions than any other firm from January 1, 2019, through May 24, 2024, according to Lex Machina.

For example, after having taken over for another firm, we secured the dismissal with prejudice in a derivative action on behalf of Six Flags, which centered on allegations related to the development of Six Flags-branded theme parks in China.

Amidst a record-level of antitrust scrutiny, we delivered a major victory on behalf of Apple in a closely watched antitrust class action due to its intersection with the DOJ's monopolization suit against Google. Also, recognized as a "groundbreaking defense win" when the *AmLaw Litigation Daily* named Boris Bershteyn Litigator of the Week, we scored a victory on behalf of Caesars Entertainment in a spate of antitrust lawsuits challenging the use of pricing algorithms.

No strangers to matters of first impression and novel areas with limited precedent, we overcame Spain's last-ditch efforts to bar enforcement of a €290 million award for irreparable damage to NextEra Energy's solar projects and, in a landmark decision, secured the successful annulment of a 2021 ICSID award that dismissed Agility's \$664 million claim against the Republic of Iraq. Only 5% of all ICSID applications for annulment have been successful in full or in part.

In the consumer products arena, we secured the dismissal with prejudice on behalf of Obagi in a traditionally plaintiff-friendly jurisdiction and obtained significant victories for TAMKO at numerous stages in purported consumer class actions.

Finally, we are equally as proud of our commitment to the well-being of our attorneys. Recently, our co-head of the New York litigation group, spearheaded a "Mindfulness for Litigators" series featuring guided meditation and training on the benefits of a mindfulness practice.

# A prospective client in crisis calls and asks why your team should be retained. What is your answer?

We are the go-to firm for clients in the midst of a crisis or clients dealing with mission-critical litigation issues, and we respond to those calls with decisive, focused action. We immediately coalesce around the prospective client and treat their crisis as our crisis to solve together. We are committed to addressing a client's crisis efficiently, because odds are that a lawyer within our firm already has solved that problem successfully before.
